UK Coaching Director John Ramshaw will once again be conducting the annual UK Soccer/Texarkana Soccer Association Soccer Camp. **John is a former professional player who holds a senior development position with the English FA in addition to being Head Coach of Hednesford Town FC, members of the Unibond Northern Premier League and winners of the 2009 Unibond Championship.** John has held a UEFA "A" level coaching license since 1980. John will be assisted by licensed coaches, and former professional players, John Cheetham, Head Coach at Rolls Royce FC, and Darren Alexander, a long-time professional striker with several successful UK soccer programs.

The morning sessions in week one, July 13 – 17, and week two, July 20 – 24, will be for players under 12 years old OR who have played less than 3 years. The participants will be grouped according to their age and skill level. The evening of the first week is for players 12 years and over AND at least 3 years playing experience. The evening camp of the second week is for girls of all ages and skill levels. Two specialty camps will be held the mornings of July 27 – 29. (1) The *Goalkeeper Camp* will be coached by Coach John Cheetham. (2) The *Striker Camp* is for any player who wants to learn what it takes to score more goals and will be coached by professional striker Darren Alexander. Both of these camps are highly recommended for developing and refining these skills. The *Pee-Wee Camp* will run July 30 – July 31 and is for 4 and 5 year olds. It is designed to introduce the young player to the fundamentals of soccer. Local TSA coaches and assistant coaches are encouraged to come out and observe as much of these camps as possible. Observing the UK Coaching staff in action will offer great ideas that can be very helpful in practices.
